5. Bar coding of each medicine should be done.
6. Regarding Point No.6 of the Checklist in the Tender Document, it is clarified that a Certificate from Govt./ Semi Govt. bodies/Commercial Institutions to whom the medicines and material have been supplied by the firm/ Bidder during last 7 years will be sufficient as a proof of experience of supply. There is no need to disclose the rate of medicines and material in the Technical Bid.

During the pre-bid meeting, the queries raised by the representative of M/s Bakson Drugs & Pharmaceuticals Pvt. Ltd. were clarified. The queries received from e-mail of the prospective bidders i.e. M/s B Jain Pharmaceuticals Pvt. Ltd., New Delhi and M/s Remedy Homoeo House, Booth No. 27, Sector 46, Chandigarh were discussed and following decisions were taken in the pre-bid meeting:-

2. Unit of Biochemic Medicines may be read as 20 gm to 25 gm instead of 20 gm.
